




CERTIFICATION OF PROJECT CONSTRUCTION CONTRACTORS



The following certification shall be signed by each contractor and subcontractor responsible for installing, constructing, repairing, replacing, inspecting and maintaining the erosion and sediment control practices included in this SWPPP; and the contractors and subcontractors that will be responsible for constructing the post-construction stormwater management practices included in this SWPPP.

"I hereby certify under penalty of law that I understand and agree to comply with the terms and conditions of the SWPPP and agree to implement any corrective actions identified by the qualified inspector during a site inspection. I also understand that the owner or operator must comply with the terms and conditions of the most current version of the New York State Pollutant Discharge Elimination System ("SPDES") general permit for stormwater discharges from construction activities and that it is unlawful for any person to cause or contribute to a violation of water quality standards. Furthermore, I am aware that there are significant penalties for submitting false information, that I do not believe to be true, including the possibility of fine and imprisonment for knowing violations."
