The Sullivan County Division of Planning and the Division of Public Works (SCDPW) have reviewed the materials submitted regarding the proposed site plan at Camp Summerville in Loch Sheldrake. The existing property has significant drainage issues discovered on a site visit by SCDPW. At the existing entrance labeled "Entrance No. 3," there is significant pooling of water which has resulted from non-compliance with a temporary access permit issued in 2008. This access was supposed to be removed following construction.

Compliance with the 2008 temporary permit will be a minimum requisite for County approval of any new work on the site. The applicant or their engineer should contact the SCDPW Permitting Office at (845) 807-0283, and incorporate resolution of the existing drainage issues into the proposed site plan. Until then, we find this application to be **incomplete**.
